

**EMERGENCY PROCLAMATION FOR
EMERGENCY SERVICES DISTRICT NUMBER 3**

WHEREAS, the World Health Organization declared the Coronavirus as a Global Pandemic on March 11, 2020; and

WHEREAS, President Trump declared a National Emergency on March 13, 2020; and

WHEREAS, Parker County declared a Local Disaster due to a public health emergency on March 23, 2020; and

WHEREAS, symptoms of the Coronavirus ranges from mild to severe and can cause complications; and

WHEREAS, the Coronavirus spreads between or among people in close contact; and

WHEREAS, the Coronavirus appears to present an imminent threat of widespread illness and requires certain emergency actions; and

WHEREAS, an Emergency Proclamation is necessary to reduce the possibility of exposure to disease and help control the risk, help promote health and avoid actions that may increase the spread of the virus; and

WHEREAS, ESD3 is charged with providing emergency services within the borders of the district;

THEREFORE, IT IS PROCLAIMED by the President of ESD3 that:

- 1) Jerry Brooks will continue to handle the order of the fire truck including all details and decisions necessary to effectuate the orderly completion of this necessary equipment;
- 2) Betty Reinert is hereby authorized to continue to write checks without the necessity of a co-signature on those checks and without the necessity of approval by a quorum of the Board on all payments of normal and necessary bills and expenses associated with the District;
- 3) Elvera Johnson is hereby responsible without further approval of the Board to coordinate with public relations and other communications that may be necessary with the public;
- 4) Ed Huddleston is hereby responsible for the day to day efforts to orderly plan and implement the building of a new fire station;
- 5) Ed Huddleston is hereby authorized to approve all spending requests that normally goes before the Board.

This Declaration shall be filed immediately with the County Clerk.

This Declaration shall take effect immediately upon filing with the County Clerk.

This Declaration shall be presented to the Board for ratification or disapproval at the Special Meeting scheduled for April 14, 2020 at 8:00 a.m. at 150 N. Oakridge Drive, Hudson Oaks, Texas 76087.

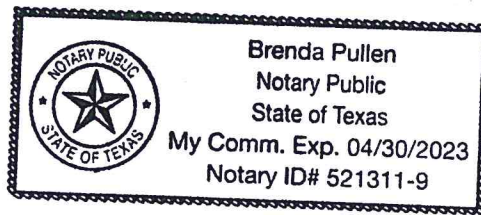
