Notice is hereby given that a **special meeting and public hearing** of the Board of Commissioners of Parker County Emergency Services District No. 3 will be held on **September 5, 2019 at 8:00 a.m.**, at the Hudson Oaks Public Safety Building located at 150 N. Oakridge Drive, Hudson Oaks, Texas, for the following purposes:

1. Call meeting to order;
2. Public Comment: In accordance with the Office of the Texas Attorney General, any public comment that is made on an item that is not on the published final agenda will be heard, but not addressed, by the Board of Commissioners. No formal action, discussion, deliberation, or comment will be made by the Board of Commissioners;
3. Conduct a public hearing on the proposal to increase property taxes:
  - (a) Open Public Hearing;
  - (b) Conduct Public Hearing;
  - (c) Close Public Hearing;
  - (d) Set and announce the date, time and place of the meeting to vote on the new tax rate;
  - (e) Authorize publication of the "Notice on Tax Revenue Increase" in The Weatherford Democrat;
4. Confer with district's attorney and consider action regarding Joint Operating Agreement with the City of Weatherford;
5. Confer with district's attorney and consider action relating to contingency plan for district fire and emergency response services, including but not limited to;
  - (a) Fire protection arrangements with other ESDs in Parker County;
  - (b) Joint agreement with the City of Hudson Oaks;
6. Discuss and consider action relating to personnel matters;
  - (a) Fire Chief
7. Confer with district's attorney and consider action relating to Hudson Oaks Volunteer Fire Department, including but not limited to the Agreement Between Parker County Emergency Services District No. 3 and Hudson Oaks Volunteer Fire Department, Inc.;
8. Discuss and consider action relating to district apparatus;
9. Discuss and consider action relating to construction of a new fire station;
10. Discuss and consider action relating to 2019-2020 District Budget;

A Citizens Comment Form must be filed with the Secretary at least 10 minutes prior to the beginning of the meeting for an individual to be allowed to speak during Citizen Comment. The individual executing the Citizen Comment Form understands that he/she is provided a limited amount of time, and that he/he may not be allowed to continue to address the Board of Emergency Services Commissioners if the comments are rude, disparaging or defamatory to any individual or entity, or the comments become disruptive to the good order of the meeting. If at a meeting of a governmental body, a member of the public or of the governmental body inquires about a subject for which notice has not been given as required by the Texas Open Meetings Act, the notice provisions of the Texas Open Meetings Act do not apply to a statement of specific factual information given in response to the inquiry; a recitation of existing policy in response to the inquiry; or, any deliberation of or decision about the subject of the inquiry shall be limited to a proposal to place the subject on the agenda for a subsequent meeting. It should be noted that pursuant to Section 38.13, Texas Penal Code, HINDERING PROCEEDINGS BY DISORDERLY CONDUCT: (a) A person commits an offense if he intentionally hinders an official proceeding by noise or violent or tumultuous behavior or disturbance; (b) A person commits an offense if he recklessly hinders an official proceeding by noise or violent or tumultuous behavior or disturbance and continues after explicit official request to desist; and, (c) An offense under Section 38.15, Texas Penal Code is a Class A misdemeanor.
